Additionally, case analysis demands extensive legal research, allowing students to enhance their ability to locate, analyze, and interpret legal sources. The process of preparing written submissions or memoranda also helps participants improve their legal writing skills, which are essential for any aspiring legal professional.

Focusing on environmental law, students gain valuable insights into the legal mechanisms used to address pressing environmental issues, including pollution, conservation, and sustainable development. This area of law is particularly important in today's context, as it equips future legal practitioners with the knowledge and tools necessary to navigate the growing challenges of environmental protection.

Furthermore, these competitions align with the global focus on sustainable development, particularly in line with the United Nations' Sustainable Development Goals (SDGs) adopted in 2015. By participating, students not only develop legal expertise but also contribute to increasing awareness about environmental conservation and sustainability, reinforcing the role of law in shaping a sustainable future.

Eligibility

The competition is open to law students, both undergraduate and postgraduate, who are currently enrolled in any recognized institution or university across India.

Submission Guidelines

1. Participants must submit a verified copy of their student Identity Card or a bona fide certificate along with their entry for verification purposes.
2. All case analyses must be written in English and submitted in Microsoft Word format (.doc/.docx). Submissions in other languages or formats will not be considered.
3. Each participant is allowed to submit only one entry. Co-authorship is permitted, with a maximum of two authors per entry.
4. All submissions must include a cover page with the author's name, institutional affiliation, course, year of study, email address, and contact number.
5. The main text of the case analysis must be free from any identifying information. Any violation of this rule will lead to immediate disqualification.
6. The analysis must be an original and unpublished work, not under review or submitted to any other publication or competition.
7. Any Manuscript beyond 10% Plagiarism shall be disqualified.
8. The recommended word limit for the case analysis is between 2000 and 3000 words, including citations.
9. All entries must be submitted by 11:59 PM on 23rd February 2025.
10. Participants must submit a case analysis on one of the provided cases related to environmental law.



Formatting guidelines

1. The submission should be typed in **Times New Roman**, Font Size **12**, with **1.5 line spacing**, and justified alignment.
2. Footnotes must be typed in **Times New Roman**, Font Size **10**, with **1 line spacing**.
3. The document should have **1 inch** or **2.54 cm** margins on all sides.
4. All citations must adhere to the **Harvard Bluebook, 20th Edition**.

Submission procedure

1. **No hardcopy submissions** are required.
2. All submissions must be submitted to the following google form

Evaluation Criteria

The submissions will be evaluated based on the following criteria:

1. **Comprehension** of the underlying essence of the case.
2. **Research** quality in terms of relevant precedents found and cited.
3. **Writing proficiency**, including content quality, logical sequencing, legal reasoning, innovative ideas, language, and grammar.
4. The decision of the judges and organising committee with regard to the event shall be **final**.
